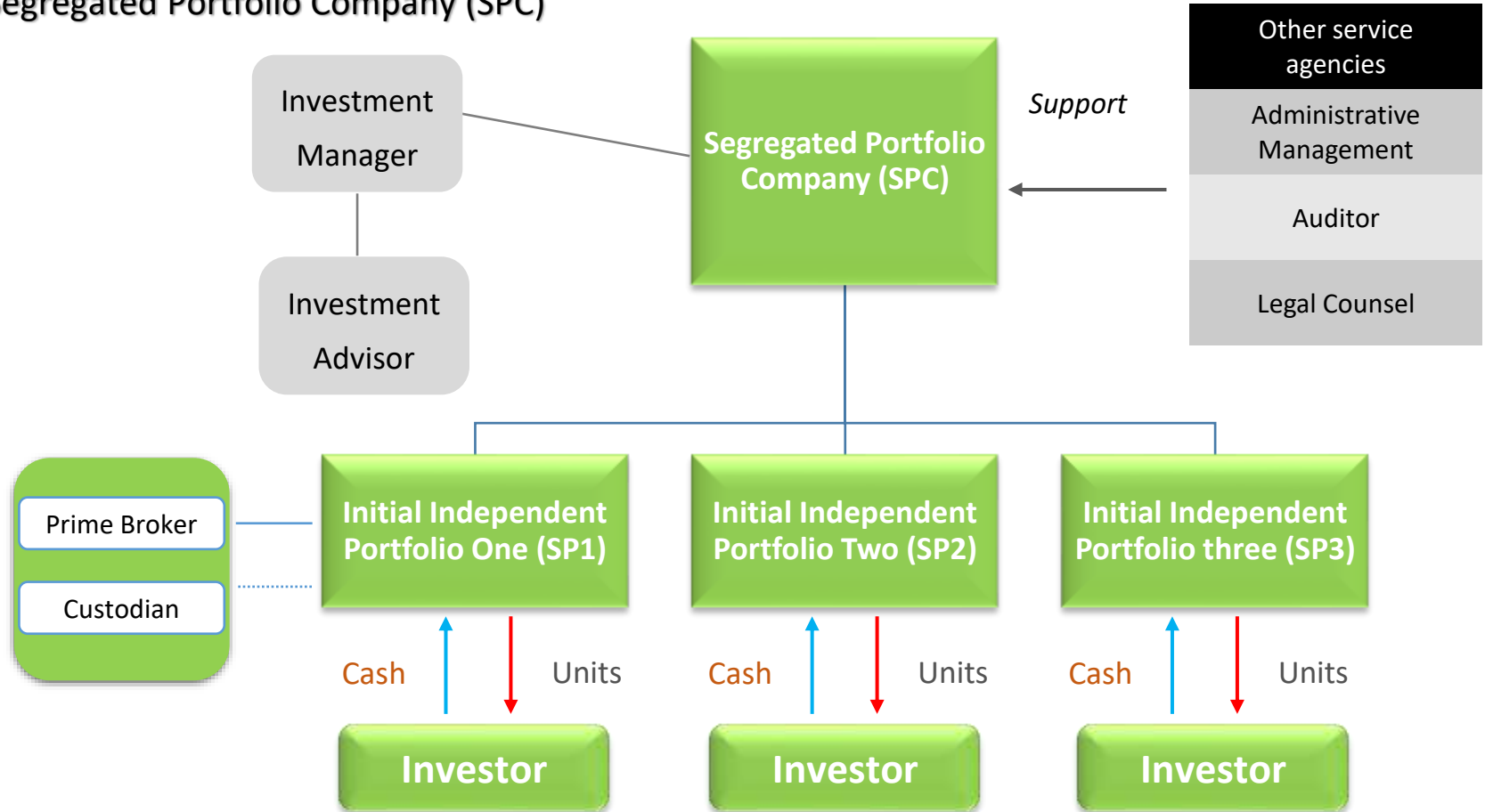

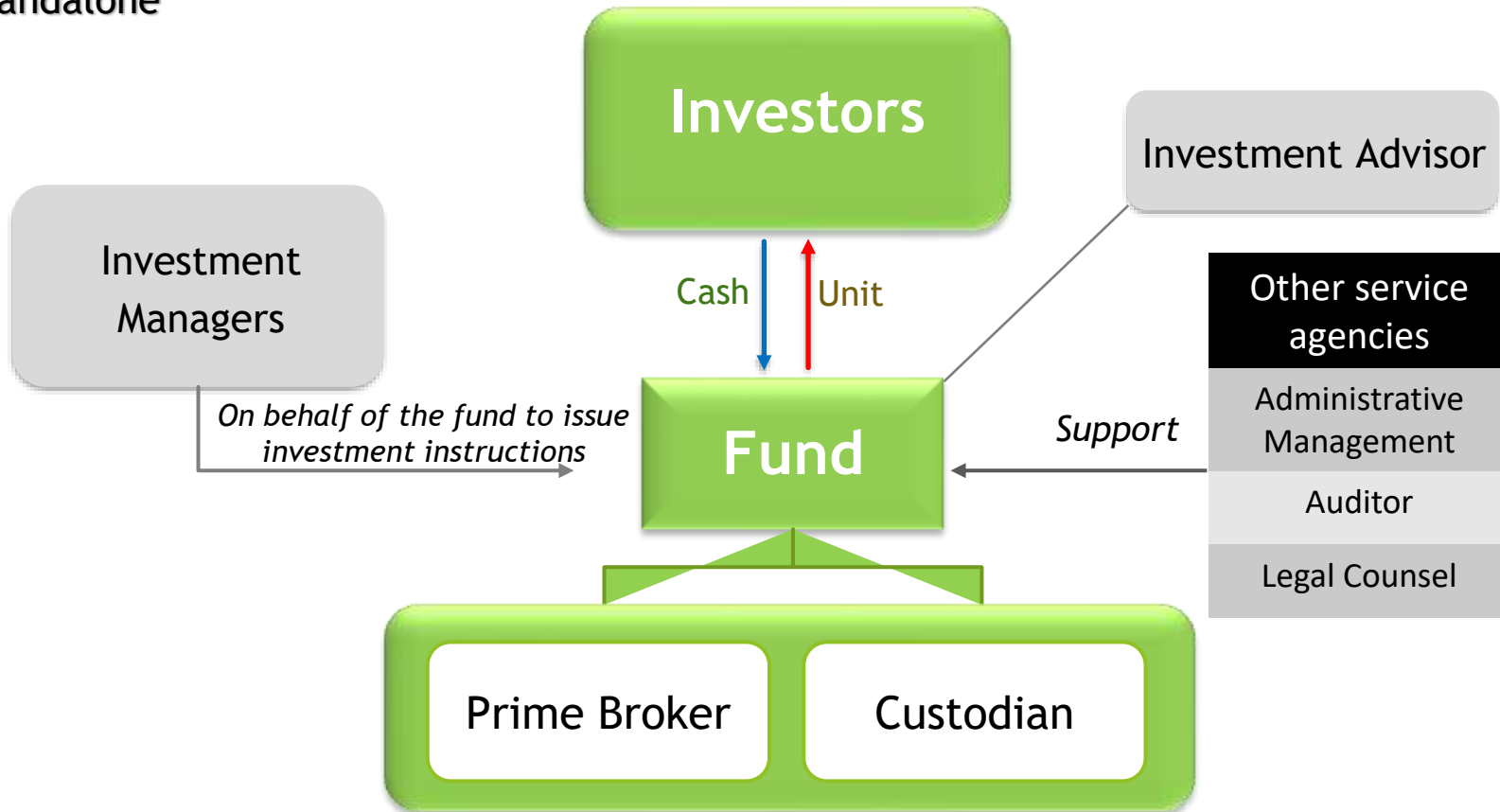
# Fund Structure (1) : Cayman Segregated Portfolio Company (SPC)

## Segregated Portfolio Company (SPC)



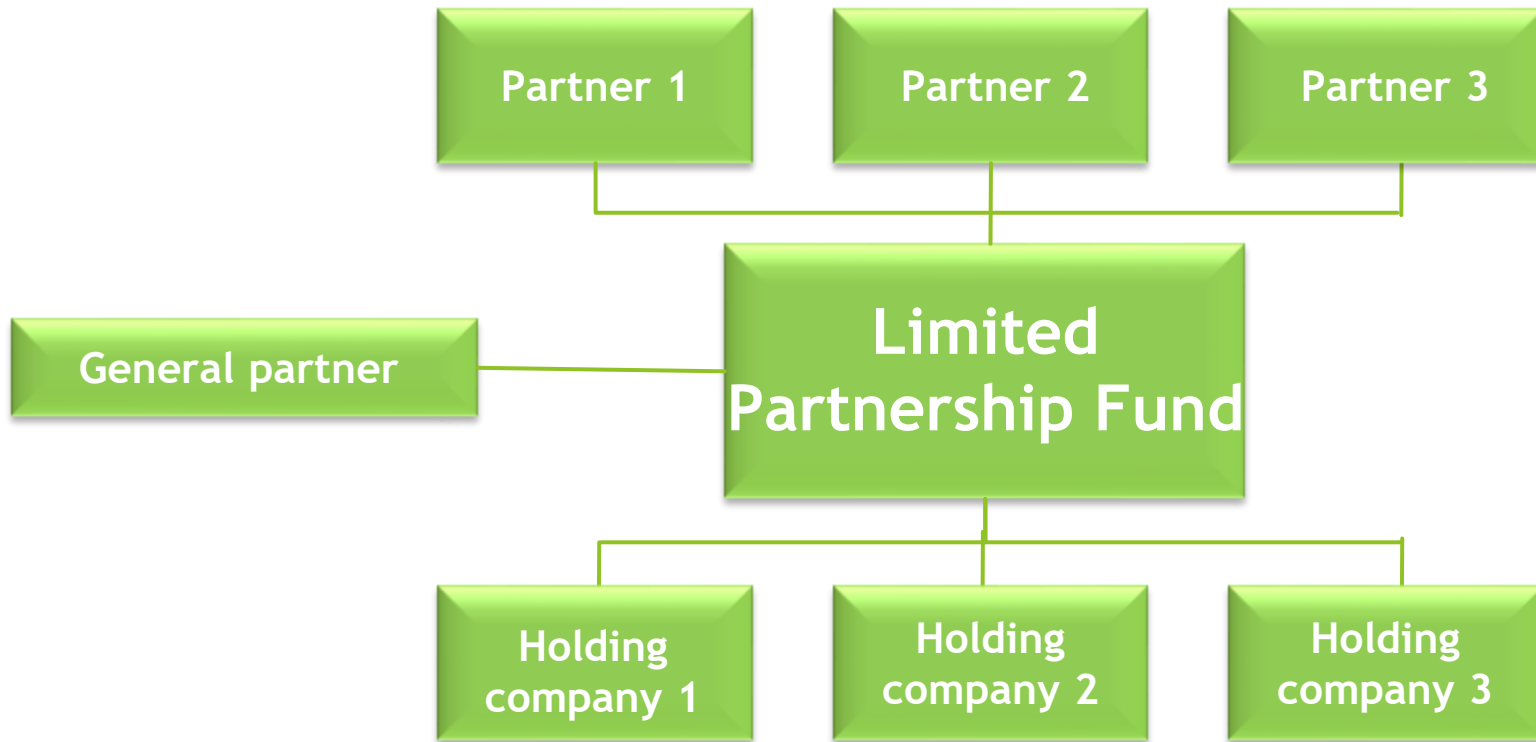
# Fund Structure (2): Cayman Standalone

Standalone



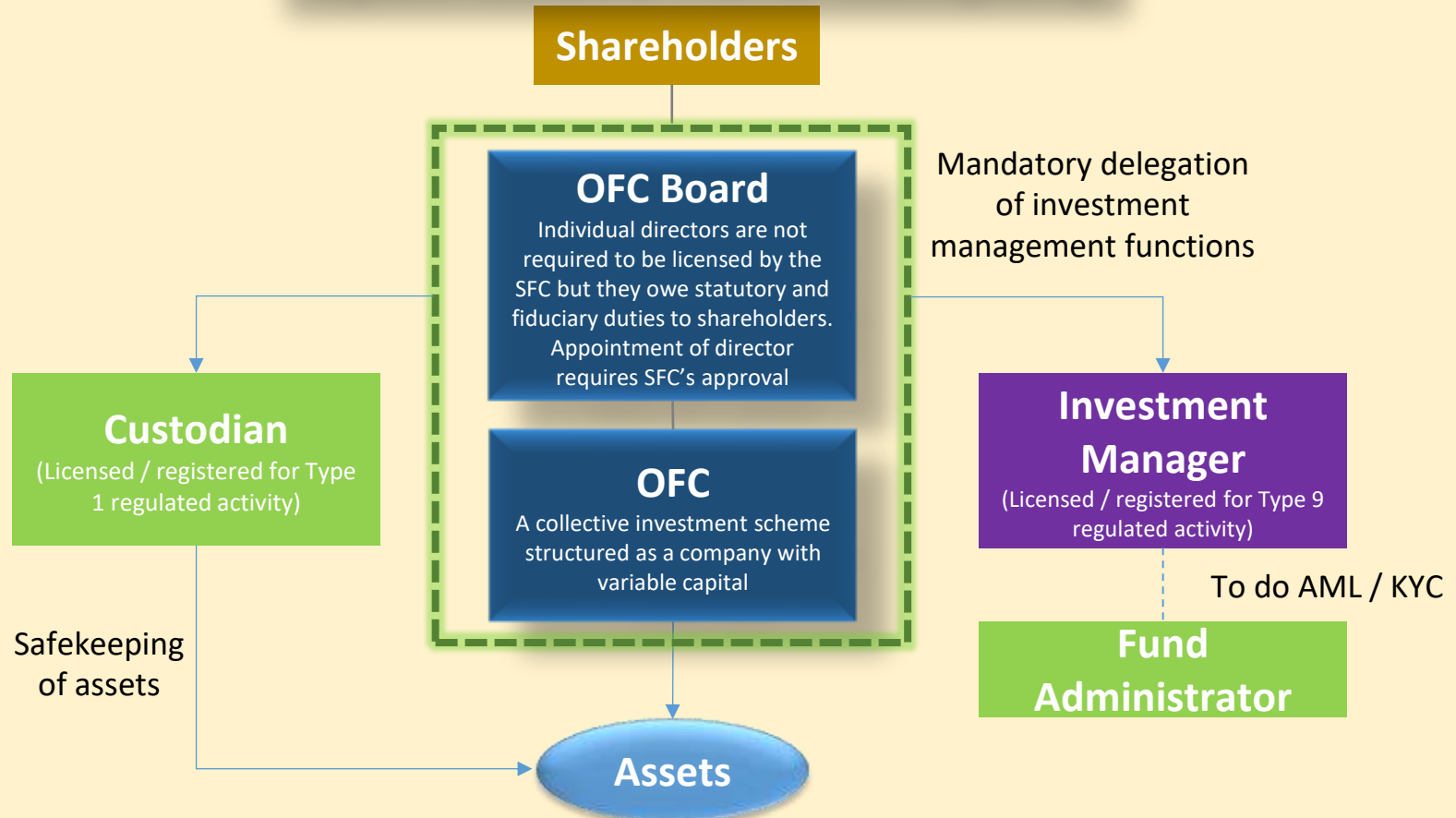
# Fund Structure (3): Cayman Limited Partnership

Limited Partnership Company



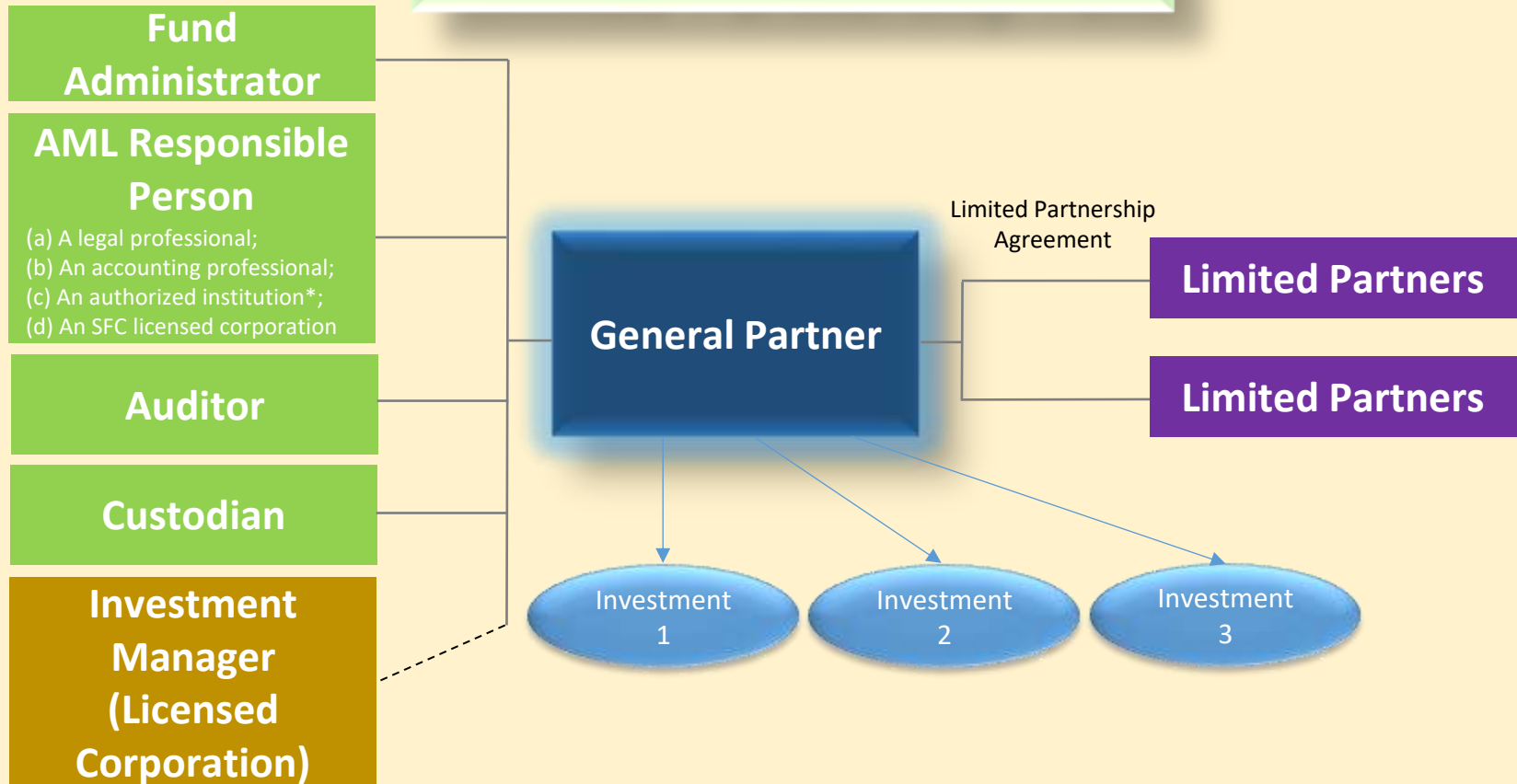
# Fund Structure (4): Hong Kong Open-ended Fund Company (OFC)

## Limited Partnership Fund

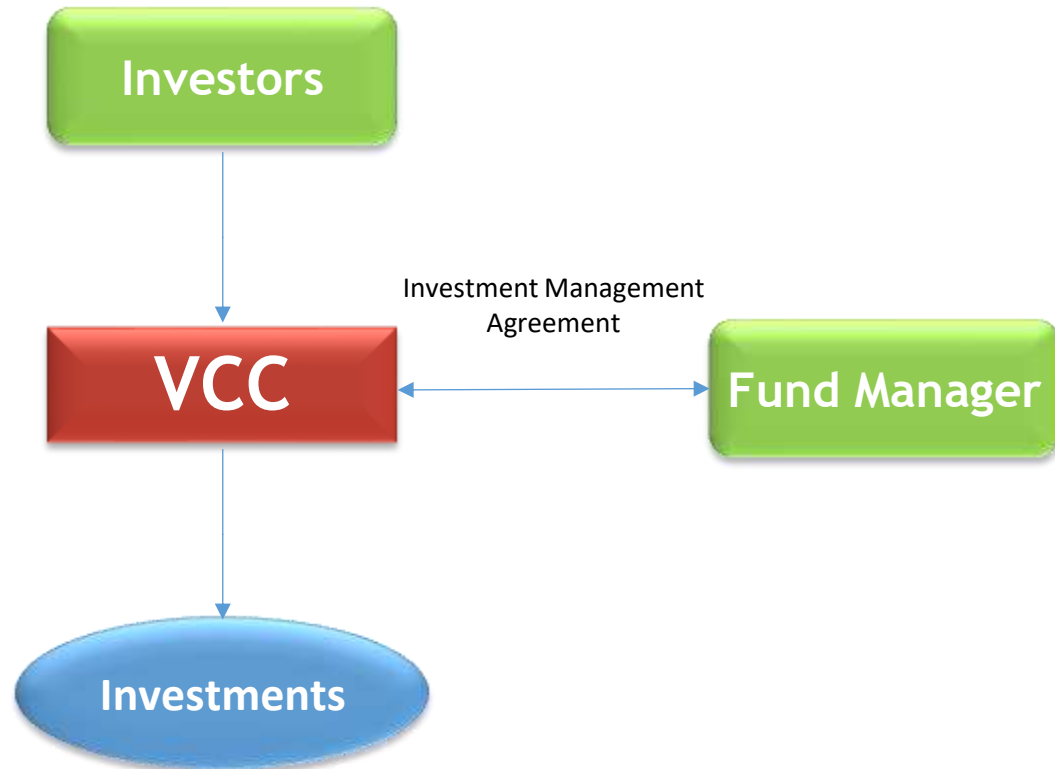

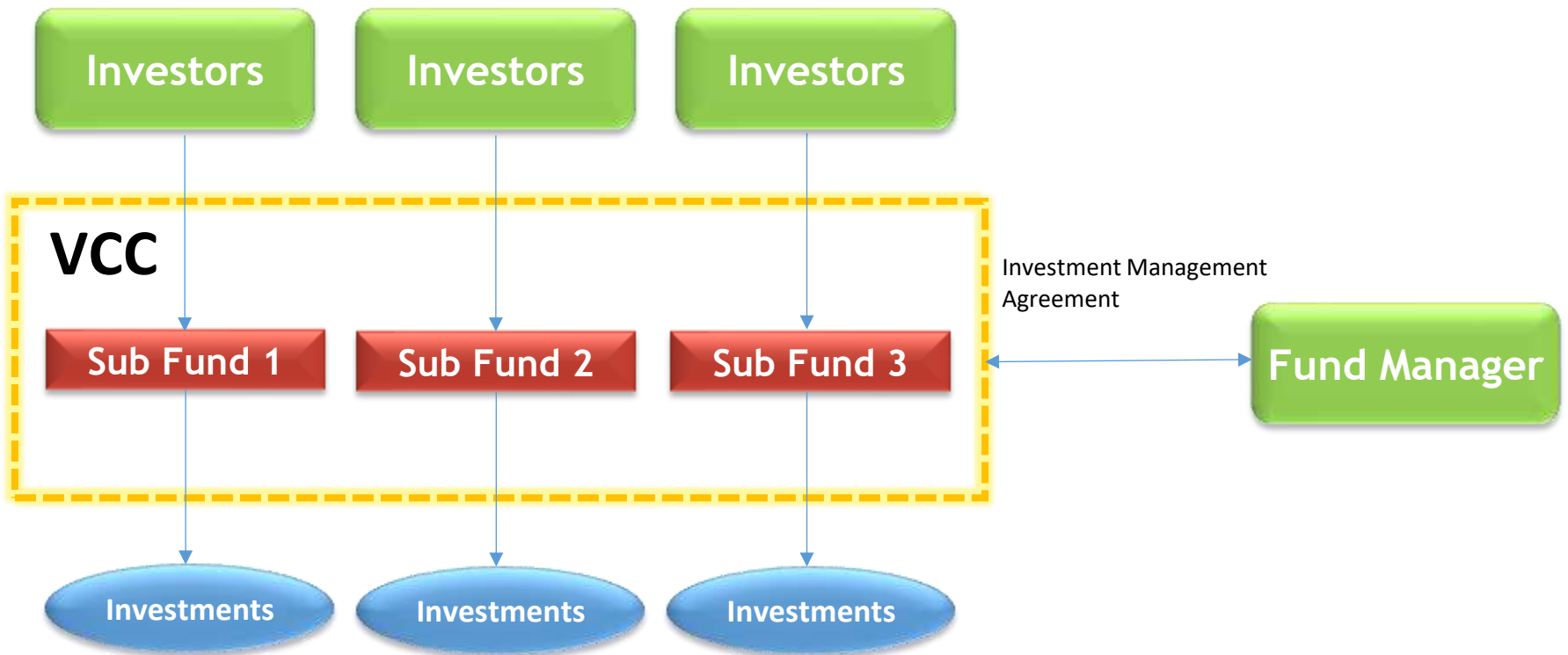
## Fund Structure (6): Singapore Variable Capital Company (VCC) - Standalone
